• A thorough yet concise overview was provided by Hugh Crowell, CAC District 4, in the latest FLOW February Newsletter (email):

Many of us are aware of the rain gardens, pervious pavement, sewer relining, etc. that were installed by the City of Columbus in Clintonville over the past few years - residents of CAC Districts 5 and 7 saw most of this construction. There has also been a similar effort going on in neighboring Linden.

Now, this work is coming to all or portions of CAC Districts 1, 2, 3, 4 and 5. It is important for residents to understand the reasons the City is performing this work, and how you can become involved in learning about and commenting on the project in 2022. Construction is planned for 2023. The first of several public meetings is coming up in mid-March.

The previous work, called Clintonville 1, was a pilot project for Blueprint Columbus, which is the City's plan to address the problem of the combined sewer overflow (CSO) located in Adena Brook on the grounds of the Whetstone Park of Roses. The Ohio Environmental Protection Agency (Ohio EPA) ordered the City to clean up this CSO, which regularly discharges untreated sewage into Adena Brook and then to the Olentangy River during and immediately after rain events. Anyone who has crossed the bridge over the brook near the Whetstone Park shelter house will have noticed the strong sewage odor, particularly right after heavy rain.

The Blueprint Columbus plan is to reduce the storm water that enters sanitary sewers in Clintonville, thereby reducing the frequency and amount of CSO discharge with the goal of eliminating it completely. Many of our older sewer pipes are leaky, and rain water gets in – this extra water overwhelms wastewater treatment facilities and sewer capacity, resulting in CSO discharge - and sewers can also back up into basements. In the Blueprint plan these problems are corrected by several means, including lining sewer main and lateral pipes using special technologies to stop leakage, and redirecting roof runoff so it does not directly enter the sewer via home foundation drains (a typical connection in houses built before 1960). There is also a home sump pump installation program to further help direct water away from the home's foundation drains. Additionally, rain gardens help to intercept, treat and slow runoff water entering the storm sewers, further benefiting downstream water quality. The new phase of this work, called Clintonville 3, is in the planning stages in 2022 with construction scheduled for 2023.
