### 7:05p.m. CPD Liaison Report

Officer Ted Stacy, CPD Community Liaison and Lt. Lipp provide general updates and information on car break-ins and advised everyone to lock their cars to prevent the most common type of theft.

## 7:20p.m. Everyday People for Positive Change

David Harewood, Campaign Director for Everyday People for Positive Change, a ballot issue committee ("Committee") passed out literature and gave a talk on the new push of the Committee to amend the Columbus City Charter to put in place a mixed-electoral system for Columbus City Council. Mr. Harwood said the Committee's proposal would install a system whereby City Council would be comprised of 10 members elected from districts, with 3 members elected at-large. If successful in gathering signatures, the proposed amendment would be placed on the ballot May 8, 2018.

During and following the presentation, Mr. Harwood took and answered questions from Commission members and residents.

## 7:38p.m. Community Update

Mr. Chris Suel, CAC Community Liaison, updated the Commission on a few continuing issues.

## 7:40p.m. Olentangy Bike Trail on West Side of River

Commissioner Vottero provided background on the trail and the opportunity the new Ohio Health development on the west edge of the river presents in connecting parts of the trail. Commissioner Vottero then read a draft of letter to Mayor Ginther encouraging the City to use the opportunity to improve the bike trail (copy of letter attached hereto as <a href="Exhibit B">Exhibit B</a>).

Discussion was had and it was determined that in addition to the Mayor, several executives from Ohio Health should receive the letter as well.

Commissioner Vottero made a motion to recommend that the Commission support and send the letter from the CAC. Motion was seconded and a vote was held. Motion passed 8-0-0.

### 7:55p.m. Code Oversight Committee Discussion

Commissioner Wetherholt spoke and moved that discussion on the Code Oversight be tabled. Motion was seconded and passed via a voice vote.

### 8:00p.m. District 9 Boundaries Task Force Report

Chair Wetherholt spoke and presented background on the purpose of the Task Force: to ensure the boundaries of District 9 as shown on the CAC website are true and accurate.

Commissioner White read a statement detailing the Task Force's findings that the boundaries of District 9 as shown on the CAC website were and are true and accurate. The Commission voted 8-0-0 to accept the findings.
