- 5. **7:20 p.m.** Treasurer's Report (Commissioner Meek) submitted memorandum of agreement—funds should be coming in soon
- 6. **7:25 p.m.** Zoning & Variance Committee (Chairperson Bagwell)
 - 1. 3381 N. High Street (North Broadway & High Redevelopment) BZA Application
 - a. To be postponed until August 6, 2015 per the applicant's request.
 - 2. 68 Walhalla BZA Application
 - a. Variance to: CC 3332.38(G) (increase garage height to 19 feet, 8 inches from maximum of 15 feet); and CC 3332.38(F) (increase garage square footage to 750 sf from the maximum of the greater of 720 square feet or one-third of the minimum net floor area for the living quarters of the principal residence); and CC 3332.38(C) (decrease the setback from minimum of 25 feet to 21 feet); and to allow for the construction of a 2-car garage with habitable space on the second floor.

Applicant Brian Burris presented reasons for new garage—does not allow for the length of a minivan and would like to have artist studio. Habitable space: Bagwell presented information on clarification of what the city considers habitable space from Jamie Friese—habitable space is different from living space—living space would include a kitchen; habitable space is simply a floor and walls.

[In an email dated July 9, 2015, chair Bagwell provided the following information:

Habitable space is allowed in detached garages with a variance to the obscure code section, 3332.35, Accessory building, which reads: "A specifically permitted principal use may include such accessory buildings as are ordinarily appurtenant thereto."

Since a garage is "ordinarily appurtenant" but habitable space in a garage is not, a variance to this code section allows the establishment of habitable space in (or often, above) a detached garage. Often times homeowners want a work space, office, studio, exercise room, heated pool house, bedroom, etc. A condition often found associated with these variances is that it shall not become a dwelling unit, which means it has cooking facilities. With a variance, we will allow just about anything just short of being a dwelling, including heat, air-conditioning and a bathroom. We don't want to see people establishing two dwelling units on the same lot, for instance, though, since that has parking implications along with a whole lot of other things. Rule of thumb is, if it's for your own use, fine. If you intend to rent it out or let grandma live there, nope.]

Committees that are not standing committees which need to be re-established each year:

Historic Building Committee—Kuhel stated that there is no authority to preserve; in the fall there will be a gallery exhibition of photographs of our historic buildings. Wetherholt moved to establish the Historic Building Committee. It was approved by voice vote: 8 yes; 0 no

Safety & Crime Committee—Jason Meek stated it had been difficult to sustain interest in this committee; the value is to have conduit between police and individuals who have sustained interest in crime prevention; Meek's recommendation was that a liaison between CPD and CAC might be more effective. Meek indicated that he would be willing to serve as that liaison. Ketcham wondered if the commission might vote at once to approve the liaison position. Wetherholt noted that appointments are up to the chair of the commission. Since liaison is not an officer position, it should be left up to the chair.

Standing Committees will be appointed in August by chair Keller. Ketcham announced that indication of interest may be sent to the commissioners' email on our website by July 13.

8. 8:15 p.m. District Updates

Vottero: meetings on Indianola bridge concern are being held; making plans for National Night Out on 8/4; also working on Crest Fest to be held on August 22.

Kuhel: encourages people to call 311 number regarding checking on speeding on NB and High

Wetherholt: attended the Columbus Blueprint Open House and recommended the cards that explain the project; recommended checking out Ohio History Connection which is making changes to Ohio Village and has a lot of good

information.

Minister: Dan has shared mailing list; encouraged people to email her to get on her list if they weren't on his list; continuing conversations with Starbucks Cull: has received emails from Bagwell's list; will look into flooding on Indianola near Acton, Blenheim, Chatham
