7:00 Call to order

Welcome, Housekeeping, Approval of Agenda – Commissioner Vottero, Chair Commissioner Introductions and District Updates

District 1, Commissioner/Chair Vottero: City organized a meeting on Blueprint with break-out sessions. Very informative and bodes well for upcoming project. Spoke with resident on Olentangy about ponding concerns; may have to reach out to adjacent property owners. Was invited to opening of Tee Jays Country Place opening and ribbon cutting.

District 2, Commissioner Peifer. Blueprint Columbus for D2 is broken up into 2 sections. Residents had questions on impact of Blueprint; they see rain gardens. Working through 2 different plans of action on the different sides of the implementation. Refer to Blueprint Columbus website for resident questions. High street and Weber mixed use development coming soon (may-July) in case anyone interested in the project.

District 4, Commissioner Crowell: No updates

District 5, Commissioner Boulton: Received a couple questions on Blueprint. Tuesday April 12th at 5pm there will be a Community Housing Network meeting. An affordable housing meeting schedule for May 10th at 5pm w/ Mike Stinziano.

District 6 Commissioner Motil: Has received several letters support, as well as opposition, of the connector project. Parking issue on Aldridge has sprung back up from Bishop Waterson students. Aldridge does not have restricted parking and therefore increases the problems there. The solution may involve visiting with Deacon of the school. Cota relations manager replied to the Commissioner regarding community garden request. Same response received; still reviewing what they're going to do. Report coming later in the meeting regarding advertising benches.

District 7, Commissioner Weinman: Was contacted by residents on Indianola about sidewalks. Potential news of Our Lady of Peace closing and giving control to Bishop Watterson.

District 8, Commissioner Garrison: – Continued issues with mail in the neighborhood. Regarding the connector, the Commissioner has received letters of support only. On the topic of Indianola project,

have received both support and opposition. Attended soft opening of Tee Jayes with Commissioners Weinman and Wetherholt.

District 9, Commissioner White: Sharon Meadows Park Geyser being repaired. Aldi well underway with construction and coming soon sign up. Golden 8 ball/billiards building reportedly sold. Listing agent not telling who bought the property. Suggests that the public monitor recorder or auditor site if anyone if that curious. Association of realtors nominates a project to support annually. Commissioner White nominated Brevort park for realtor care day. Recognized Ryan Foshee, Chair of Greenspot committee; applied for a grant from FSWC district and won \$1000 for servicing the fire station. \$200 for signage and \$800 on plants.

7:23 Conclusion of discussion on Indianola Complete Streets Study

Due to extensive public comment at the last meeting, not enough time had been given for Commission discussion on the best way to capture the sentiment and present to the city.

The options available was writing of a letter or a resolution. Both options were prepared and discussed among the commission. Commissioner Weinman read aloud the contents of a draft resolution and motioned for approval.

Omission of the intent of the Clintonville Neighborhood Plan was mentioned by Commissioner White. Commissioner Motil felt that the letter better captured the sentiments of all parties with sufficient context.

Some public comment was received and a vote was taken on the resolution.

The vote was 4 yes, 4 no, motion failed.

The contents of the draft letter was then read aloud by Commissioner Boulton.

Commissioner Weinman motioned to table the letter with a second from Commissioner White. Tabling was opposed; 7 against, 1 for.

Modifications to the letter to align with the resolution seemed somewhat agreeable to the Commission. Modifications were then made by Commissioners Boulton and Peifer.

7:45 Mary Rodgers - Clintonville Historical Society

Noted the 50th Anniversary of the Clintonville Arts Guild

City of Columbus has began repair of mural/fence/wall on North Broadway. Flat black, a local commercial team of artists going to do a restoration of 500SF of patches to the wall. Color matching will be made to the current faded color as well as content. Beginning April 21st, the cost is \$30,000. Historical Society raised funds and will be paying that bill. Initially murals were on west of railroad tracks and extended over time eastwards. Problems with the artist and contracts as well as the railroad raining down effluence from above have caused a state of disrepair. Latest plan will be that murals to the East will be covered with dark grey paint. Flat black gave some design input on what goes on walls to the East of tracks. Historical Society looking to get community support and engage CAC. Also, it is the 50 year anniversary of the Clintonville Art Commission.

8:15 Conclusion of discussion on Indianola Complete Streets Study (cont'd)

With modifications completed on the letter (now resolution with letter format language), a vote was taken. The modified language was unanimously approved by the Commission.

8:27 Advertising Benches Throughout Clintonville

Commissioner Joe Motil gave overview of the advertising benches issue and how it has been looked into over the years but no progress made. In 1989, as a result of a court case with the city filing against bench company, it was uncovered that in 1972 the city gave permits for benches. City then accepted grandfather status of benches in 1989. Another issue aside from the aesthetic is that some benches in the sidewalk pose accessibility issues. Despite public service dept contacted, not much change. The feeling is that advertising benches are trash collectors and that the ads are often promoting themselves

They are featured only in Columbus as a result of the benches formerly in Cincinnati and banned there. There is now a 311 request for advertising benches in R-O-W. Public is encouraged to report the locations to allow city to track the location and quantity to back check things against the initial allowance on the benches from 1972.

8:44 Planning and Development Presentation of Neighborhood Survey Results Planning and Development Committee Chair – Andrew Overbeck

Chair Overbeck gave overview/updates of the Mobility framework survey

780 responses received and gave important insight into where the community desires/needs amenities like sidewalks, traffic calming, bike infrastructure, and streetscape appearance improvements.
